- 1 Separating intergroup attitudes from other political attitudes is important, but difficult.
- 2 Widely used racial attitude scales do not measure what they are commonly thought to measure.
- 3 Racial attitudes in American politics may be characterized by broad resentment, perhaps underpinned by Just World Belief.

- 1 Over the past few years, blacks have gotten less than they deserve.
- 2 Irish, Italian, Jewish, and many other minorities overcame prejudice and worked their way up. Blacks should do the same without any special favors.

- 4 Generations of slavery and discrimination have created conditions that make it difficult for blacks to work their way out of the lower class.

Four question Racial Resentment Scale (Kinder and Sanders, 1996), ANES, CCAP, CCES.

- 2 Irish, Italian, Jewish, and many other minorities overcame prejudice and worked their way up. <u>Lithuanians</u> should do the same without any special favors.
- 3 It's really a matter of some people not trying hard enough; if Lithuanians would only try harder they could be just as well off as whites.
- 4 Generations of slavery and discrimination have created conditions that make it difficult for blacks to work their way out of the lower class.

Four question Racial Resentment Scale (Kinder and Sanders, 1996), ANES, CCAP, CCES.

Modern Racism

Racial Resentment: Mean of 5 item Likert Agree–Disagree scale (items 1 and 4 reverse coded).

Old-fashioned Racism

- (1) desire for social distance between the races, (2) beliefs in the biological inferiority of blacks, and (3) support public policies insuring racial segregation and formalized discrimination.
 - 1 How much would you favor or oppose a close relative or family member marrying a black person?
 - 2 On the average, blacks have worse jobs, income, and housing than white people. Do you think these difference are because most blacks have less inborn ability to learn?
 - 3 Do people in these groups tend to be unintelligent of intelligent?

Our intervention.

- If respondents will respond the same to racial resentment questions, *regardless of the target group*, these scales are not a reliable measure of specific anti-Black affect.
- Modern racism and conservatism may both spring from common "Belief in a Just World."

Classic debate...

Do Modern Racism scales measure a

a "blend" of anti-Black affect and traditional values (Kinder and Sears, 1981)?

or

non-affective conservative ideology (Sniderman and Tetlock, 1986)?

Our intervention...

- If respondents will respond the same to racial resentment questions, *regardless of the target group*, these scales are not a reliable measure of specific anti-Black affect.
- Modern racism and conservatism may both spring from common "Belief in a Just World."

Why might responses to Modern Racism scales *not* change, regardless of the target group?

- 1 Motivation for "Belief in a Just World," or belief that people get what they deserve (Jost, et Al, 2003) ("If blacks would only try harder...").
- 2 The attribution of stereotypes of inadequate work-ethics to low-status groups can be seen across time and place (Sidanius and Pratto, 1999).

Empirical Demonstrations

- 1 Do modern racism scales measure attitudes specifically targeted at African Americans?
 - 1 Do modern racism scales yield different responses when other groups are used?
 - 2 Do modern racism scales explain policy preferences when other groups are used?
- 2 Do modern racism scales capture racial animus or racial sympathy?
- 3 Racial attitudes in Trump era: what might explain conservatives' non-specific attitudes toward African Americans?

Design

- 1 Two sets of questions (set ordering randomized):
 - 1 Anti-Black Racial Resentment Questions
 - Standard 4-Question Scale
 - Modified 3-Question Scale (no slavery question)
 - 2 Non-Standard Questions using another target group (Albanian, Angolan, Hispanic, Jordanian, Surinamese, Taiwanese, Bahrani, Bhutanese, Lithuanian, Mauritanian, Uruguayan, American, Guayanese, Ivoirian, Guyanese, Maltese, Niuean, and White)
- 2 Questions about attitudes toward racialized policies and Just World Belief scale.

Compare the distribution of responses, between subjects, across the two conditions.

Sample¹

6,699 total subjects from 12 trials (Amazon Mechanical Turk and the Harvard Digital Lab for the Social Sciences (DLABSS), with a nationally representative sample from Time-sharing Experiments in the Social Sciences (TESS)).






Anti-Black Racial Resentment by Three and Four Question Scales






Then why is Modern Racism correlated with everything?

Modern racism scales appear to measure primarily specific **racial sympathy** rather than specific racial animus. *It is liberals who are driving the relationship with Obama's policies.*

- "two sides of racialization" (Tesler and Sears, 2010)
- "[racial resentment scales] distinguish between those whites who are generally sympathetic toward blacks and those who are generally unsympathetic" (Kinder and Sanders, 1996)



Why are attitudes so consistent among conservatives?

Just World Theory (Lerner, 1980)

- "the core ideology of conservatism stresses resistance to change and justification of inequality." (Jost et al., 2003)
- People with high just world belief are motivated to believe that "people get what they deserve."

Belief in a Just World Scale (Lipkus, 1991)

- 1 I feel that people get what they are entitled to have.
- 2 I feel that a person's efforts are noticed and rewarded.
- 3 I feel that people earn the rewards and the punishments they get.
- 4 I feel that people who meet with misfortune have brought in on themselves.
- 5 I feel that people get what they deserve.
- 6 I feel that rewards and punishments are fairly given.
- 7 I basically feel that the world is a fair place.

Takeaway

- Liberals: belief in Just World and resentment toward African Americans are strongly related.
- Conservatives: belief in Just World correlated with resentment toward all groups.

Takeaway

- Liberals: belief in Just World and resentment toward African Americans are strongly related.
- Conservatives: belief in Just World correlated with resentment toward all groups.

Summary

- 1 Modern Racism scales are not capturing an attitude specifically targeted at African Americans.
- 2 Modern Racism is closely tied to attitudes about Obama, not because of conservatives, but because of liberals.
- 3 Conservatives resent a broad range of outgroups, possibly because of Just World Belief.

What does this say about racial attitudes?

- Arguably, failing to recognize unique historical hardship of African Americans is racism.
- 2 However, there is also a risk if scholars arriving at the same conclusion no matter what the question.

Summary

- 1 Modern Racism scales are not capturing an attitude specifically targeted at African Americans.
- 2 Modern Racism is closely tied to attitudes about Obama, not because of conservatives, but because of liberals.
- 3 Conservatives resent a broad range of outgroups, possibly because of Just World Belief.

What does this say about racial attitudes?

- Arguably, failing to recognize unique historical hardship of African Americans is racism.
- 2 However, there is also a risk if scholars arriving at the same conclusion, no matter what the question.

Bringing Just World to bear on other groups...

- 1 A broadening of the set of salient outgroups due to the changing nature of diversity, conflict, and immigration.
- 2 An embrace of populist rhetoric by conservatives.

Populism and Outgroups (1976)

"In Chicago, they found a woman who holds the record, She used 80 names, 30 addresses, 15 telephone numbers to collect food stamps, Social Security, veterans' benefits for four nonexistent deceased veteran husbands, as well as welfare. - "If you were a Muslim you could come in, but if you were a Christian, it was almost impossible...I thought it was very, very unfair. So we're going to help them." January 2017





What if conservative attitudes are a result of anti-Black attitudes?

We also measure conservatism by Modern Sexism (Swim et Al, 1995) and foreign policy beliefs and find the same relationship.

Does this represent a cohort effect or time effect?

- 1 Modern racism scales have roots in Symbolic Attitudes (e.g., Sears (1980)) and should be socialized early in life.
- 2 But, there is no apparent relationship between age and differences in resentment.
 - 1 Conservatives have never had specific attitudes about Blacks?
 - 2 Conservatives once had specific attitudes about Blacks but recent political climate has brought Just World Beliefs to bear on other groups?
